1 FOR AN ACT ENTITLED, An Act to authorize the payment of lease rental obligations to the
2 South Dakota Building Authority by the Bureau of Finance and Management, to make an
3 appropriation therefore, and to declare an emergency.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

5 Section 1. There is hereby appropriated from the general fund fifty-six million two hundred
6 fifty-seven thousand two hundred fifty-one dollars (\$56,257,251) to the Bureau of Finance and
7 Management to be transferred to the South Dakota Building Authority public building fund for
8 the purposes of prepaying lease rental obligations.

9 Section 2. The funds appropriated in section 1 of this Act shall be used to pay or prepay
10 lease rental and associated fees in the amounts specified below to the South Dakota Building
11 Authority relating to the leases between the South Dakota Building Authority and the
12 departments or offices and the related real or personal property financed by the South Dakota
13 Building Authority all as described below:

14 (1) Lease rentals and fees in an estimated amount of eleven million eighteen thousand



1 eight hundred fifty-three dollars in connection with the lease between the South
2 Dakota Building Authority and the Department of Human Services relating to the
3 George S. Mickelson Center for the Neurosciences financed with the proceeds of a
4 sale by the South Dakota Building Authority of series 1992 bonds and refinanced
5 with proceeds of series 1993A lease revenue trust certificates;

6 (2) Lease rentals and fees in an estimated amount of six million forty thousand two
7 hundred ninety-three dollars in connection with the lease between the South Dakota
8 Building Authority and the Office of Attorney General and Department of Public
9 Safety relating to the George S. Mickelson Criminal Justice Center financed with
10 proceeds of the South Dakota Building Authority's series 2005B bonds;

11 (3) Lease rentals and fees in an estimated amount of thirty-two million four hundred
12 sixty-five thousand five hundred forty dollars in connection with a lease between the
13 South Dakota Building Authority and the Board of Regents relating to the portion of
14 the costs of the science facilities and laboratories at various public universities
15 supported by rent paid from general fund appropriations by the Legislature and
16 financed by proceeds of the South Dakota Building Authority's series 2008 bonds;
17 and

18 (4) Lease rentals and fees in an estimated amount of six million seven hundred thirty-two
19 thousand five hundred sixty-five dollars in connection with a lease between the South
20 Dakota Building Authority and the Department of Human Services relating to the
21 George S. Mickelson Center for the Neurosciences dietary wing financed with the
22 proceeds of the South Dakota Building Authority's series 2010B bonds.

23 Section 3. The South Dakota Building Authority may enter into an irrevocable escrow
24 agreement to provide for the defeasance and payment of the series 1993A lease revenue trust

1 certificates, the series 2005B bonds and the series 2008 bonds issued to finance the costs of the
2 buildings and other real or personal property described in subdivisions (1), (2) and (3) of section
3 2 of this Act. The authority may enter into such other arrangements to pay or prepay, from time
4 to time, any governmental expenses permissible under chapter 5-12, including payment or
5 prepayment of debt service and associated fees and expenses relating to series 2010B bonds
6 issued to finance the costs of the buildings and other real or personal property described in
7 subdivision (4) of section 2 of this Act. The authority may contract with a third party for any of
8 the purposes of this section. Upon determination by the authority of the amounts necessary for
9 payment or prepayment of the bonds and other governmental expenses described in this section,
10 and any associated fees and expenses, any remaining funds shall be transferred to the general
11 fund at the end of the fiscal year in which this Act was enacted. Thereafter, as of the end of each
12 fiscal year to and including the fiscal year ending June 30, 2021, the South Dakota Building
13 Authority shall file an annual report with the Bureau of Finance and Management specifying any
14 lease rentals, any fees received pursuant to this Act, and any interest earnings thereon, which
15 the authority has determined are no longer expected to be required for the purposes set forth in
16 section 2 of this Act. Any such amounts not then expected to be required shall be deposited into
17 the general fund with thirty days of the filing of the annual report. Any lease rentals and fees
18 received by the authority pursuant to this Act, or interest earnings thereon, which are not applied
19 by June 2, 2021, to pay or prepay amounts described in section 3 of this Act, shall be deposited
20 into the general fund by June 30, 2021.

21 Section 4. The commissioner of the Bureau of Finance and Management shall approve
22 vouchers for payment and the state auditor shall draw warrants to pay expenditures authorized
23 by this Act.

24 Section 5. Any amounts appropriated in this Act not lawfully expended or obligated by

1 June 30, 2015, shall revert in accordance with the procedures prescribed in chapter 4-8.

2 Section 6. Whereas, this Act is necessary for the support of the state government and its
3 existing public institutions, an emergency is hereby declared to exist, and this Act shall be in
4 full force and effect from and after its passage and approval.
